

### **HOW DO I VOTE?**

Members will receive a voting packet in the mail with instructions for electing directors and nominating committee members around March 24. Follow the instructions to cast your vote by the April 17 deadline.

There are three director positions and three nominating committee positions to vote for. Please vote for the candidates in all three districts, even if you do not live within that district. Return the ballot in the provided postage-paid envelope and send it directly to Survey and Ballot Systems. To ensure your vote is counted, please do not send in your ballot with your bill or bring the ballot to the office.

### WHEN DO I VOTE?

Voting will open March 24, 2022, and closes April 17, 2022, at 5:00 p.m. ET. Please follow the instructions for casting your vote included in the voting information packet you receive in the mail.

- The type of problem you are experiencing flickering lights, complete power outage, etc.
