MESSAGE FROM THE CEO Reviewing Cost of Services



MARY JO THOMAS CEO At WWVREMC, we work hard every day to provide you with the best service possible while also striving to keep rates low.

However, just like a gallon of gas costs more than it did just a few months ago,

costs to deliver electricity have increased. Earlier this year our power supplier, Hoosier Energy, completed a redesign of their wholesale power rate. A periodic review is important, which is why we had also started a cost-of-service study. This review helps to ensure our current rates recover the current cost of things like materials, labor and the price of power in a fair manner across all types of members.

A lot has happened in the world and the energy industry since I first wrote about the forecast for rates beyond 2022. The results of events are being felt everywhere, including here at WWVREMC. While a transition in the energy market is occurring to renewable energy, the two most common forms of electrical generation remain based on coal and natural gas. Coal prices have increased by 295% and natural gas costs have increased by 250% since last year. These price changes in fuels are reflected in our monthly Wholesale Power Adjustment (WPA) rate. In 2022, this increase was an average of 6% higher, as reported in June 2022. The primary drivers of the increase are the ongoing war in Europe, fuel supply constraints, fuel and power price volatility all factors that can be viewed with a great deal of uncertainty.

An analysis of our rates based on the new cost of service study has been completed. At the October 25, 2022, board meeting these proposed rates from the study were discussed and approved by the board of directors. A rate increase of approximately 8% will take effect in April 2023.

The cooperative will continue modernizing rates by moving fixed charges into the facility charge and variable charges into energy and demand charges. The new rates reflect this trend, the current cost to serve and the change in resources from our power supplier to a more diverse portfolio.

We will report more on the details of the rates and how they will affect your bill in upcoming newsletters. Updated rates will also be shared with members at the 2023 annual meeting. 2022 YEAR ENDS WITH CAPITAL CREDITS RETURNED TO WWVREMC MEMBERS

Your WWVREMC Board of Directors has reviewed the financial condition of the cooperative and is pleased to announce the retirement of \$885,000 in capital credits. Following the cooperative's capital credits retirement policy, 70% of the Generation & Transmission margins from 1993, and 10% of the most recent year 2021, will be retired and returned to members.

How much will you receive?

The amount you receive will be based on two factors; your length of membership with the cooperative and the amount of power used during the period being retired. Refunds less than \$10 will be applied as a credit on your December electric bill. If your refund is more than \$10, you will receive a check in the mail. Checks will be mailed by the end of the year.

About Capital Credits

Unlike investor-owned utilities that maximize profits to pay their shareholders, not-forprofit electric cooperatives do not exist to earn a profit. You receive capital credits because you are more than a customer; you are an owner of WWVREMC. The hidden account number is 71601. These credits represent your ownership in WWVREMC and are one of the unique and rewarding benefits you enjoy as a member of the cooperative.
